Introduction:

Ability to take advantage of bulk purchasing discounts: By purchasing goods and services in bulk through cooperative contracts, participants can receive discounts not available through individual purchasing.



Streamlined procurement processes and reduced administrative costs: According to the National Cooperative Purchasing Alliance, cooperative contracts can reduce procurement costs by 50-75% compared to individual purchasing.

With cooperative contracts, the terms are often already in place, allowing agencies to skip ahead in the process. Goods and services are obtained more quickly and with less operational overhead.

Agencies have more time to research the market and land on a contract that best meets their needs.

Understanding How to Manage Cooperative Contracts

Preparing for Cooperative Contracts

- ldentifying potential participants and coordinating with them to form the cooperative:

 This can involve reaching out to other government agencies, organizations, and businesses in your area or industry.
- Developing a clear procurement process and timeline: This can include establishing a lead agency or organization, setting procurement goals and objectives, and determining the steps and timeline for procurement.
- **Establishing a lead agency or organization to oversee the procurement process:** The lead agency or organization is responsible for overseeing the procurement process and ensuring that it is efficient and effective.

Supplier Selection and Evaluation

- Conducting a competitive bidding process to select suppliers: The competitive bidding process involves soliciting proposals from suppliers and evaluating them based on factors such as cost, quality, and delivery time.
- **Evaluating proposals from suppliers to ensure they meet the needs and requirements of participating agencies** This involves reviewing the proposals and verifying that they meet the specifications and requirements outlined by the cooperative.
- Ensuring suppliers provide high-quality goods and services at competitive prices: The lead agency or organization should regularly monitor supplier performance and make changes if necessary to ensure that participants are receiving high-quality goods and services at competitive prices.

Implementing Cooperative Contracts

- Negotiating pricing and terms with selected suppliers: The lead agency or organization will negotiate pricing and terms with the selected suppliers to ensure that the cooperative is receiving the best possible deal.
- **Establishing a distribution center to receive, store, and distribute goods and services:** The distribution center is responsible for receiving, storing, and distributing goods and services to participating agencies.
- Providing participating agencies with real-time inventory information: The distribution center should provide real-time inventory information to participating agencies, allowing them to make informed purchasing decisions.

- **Regularly monitoring the performance of suppliers and the procurement process:** The lead agency or organization should regularly monitor supplier performance and the procurement process to ensure that they are efficient and effective.

- ldentifying opportunities for improvement and making necessary changes: The lead agency or organization should identify areas for improvement and make changes to the procurement process as necessary to maximize efficiency and savings.

- Cooperative procurement contracts allow governments to utilize procurement resources better for other tasks and contracts.
- Cooperative procurement can help suppliers realize diversity initiatives.
- Ultimately, people benefit from cooperative procurement through lower costs of government, more efficient government operations, and better application of resources.

Case Study



Q Overview

A county government in a Northeast State was looking to implement real-time monitoring and alerting based on security events in their infrastructure.

They decided to do an RFP for selecting an integrator who will choose the security product and implement it across the county. They realized that selecting an integrator would have to go through an RFP and take over one year to complete.




